genocide is happening right in front of our eyes. Before and after satellite images are documenting the genocide of Rohingyas live, as villages are torched by the Burmese military and then bulldozed to destroy evidence of the genocide. No genocide has been as well documented in history as this one.

But the world is once again failing to stop a genocide. Never again is happening again.

Failure to act is encouraging other extremists. Burma, intoxicated by the world's inaction, is now bombing a Christian ethnic group; India has declared 13 million of its people—mostly Muslims—non-citizens and as I write this, 300 properties of Muslims including mosques have been attacked in Sri Lanka.

Thanks to your efforts the United States House of Representatives has the unique distinction of passing two resolutions in support of Rohingya security and citizenship. This is an excellent start. But we must encourage our government to do more. Stakes are high. The whole region may ignite.

We can definitely do better. But that will require all people of conscience to demand action - as we did in Bosnia.

WHO ARE THE ROHINGYAS?

The Rohingya are indigenous people of Burma, living in their ancestral homeland.

he Rohingya are indigenous people living in their ancestral homeland—Arakan. Arakan state, now called Rakhine, has been an independent state where Buddhist and Muslims co-existed for centuries ruling themselves.

Historically, Burma was never a country but a group of kingdoms. Burmans occupied Arakan for a mere 40 years before they were defeated by the British, and modern borders drawn. In this sense, Rohingya did not come to Burma but Burma came to them. Currently, 40% of the population of Myanmar are minorities and 60% are Burman.

Rohingyas were citizens in Burma: voted, elected their representatives, served in the military, in government and the police force. However, the 1982 Citizenship Act, passed by the military regime, took away their citizenship. This policy launched a slow, increasingly destructive genocide which is in full swing now. Rohingyas have been living under apartheid for decades. They cannot attend school, hold jobs, marry, or travel freely.

Most Rohingya are Muslims. There are some Hindu and Christian Rohingyas as well, many were among those attacked and forced to flee to Bangladesh. Since 1982, repeated military attacks have displaced over a million Rohingyas.

The U.N. considers Rohingyas the most persecuted minority in the world.

WHAT FATIMA DID NOT TELL US WAS THE REAL STORY!

mam Mujahid of Burma Task Force met Fatima a few days after her rickety boat was rescued by Indonesian fishermen. Why did this young Rohingya girl leave Burma on her own? Why did her parents sell everything they owned to put their beloved daughter on a wooden boat transversing treacherous seas and an uncertain future?

Fatima shared her real name and other details. She, like others, was fleeing the genocide in Burma. Throughout the conversation, her eyes remained furious and her face tense.

As rape has become an instrument of genocide in Burma, parents in Myanmar are selling all they have to send their daughters out of Burma so that they are not raped by the military or Buddhist extremists.

"That was not in my mind when I asked Fatima why she left Burma. That was the first time her furious eyes started looking downward. It was, however, her silence that spoke loud and clear, as my heart sank," shares Imam Mujahid.

"Ya Allah, I told myself. I did not mean to raise that question. I raced to change the topic and made another mistake as a Rohingya refugee teacher translating for me started giving words to her silence, telling me how the Rohingya women are raped.

"I will go anywhere my Rab would take me."

I wish I had remained quiet. Her lowered eyes, her haya or modesty, was enough to convey her trauma. I asked Fatima about her future. "Where would you like to go?"

The furious eyes were back. She looked up. Still silent as if questioning my wisdom, her eyes asking me why. She finally spoke, "Anywhere my Rab would take me."

My heaving shook my phone as I recorded her story. Her face blurred. I had to stop. But Fatima was tearless. Her tears long gone. May Allah keep her safe. May Allah help us keep her in our hearts and duas. May Allah help us all to translate our anger into an energy of thoughtful struggle to liberate the enslaved Rohingyas and to end the genocide."

HOW BURMA TASK FORCE

2012-2016

WITNESS TO GENOCIDE: UN WHAT BODI SAW

he former chair of Tula Toli village council, Bodiur Rahman, estimates that 1,700 Rohingyas were killed in his village alone. That is more than half of all Rohingyas of the village. Many survivors revealed that the Rakhine Buddhist mayor of the village placated the Rohingyas a day before the massacre - their houses would be torched but no one would be killed.

The next day, helicopters heralded the arrival of the military, which massacred villagers as their homes were ransacked and torched. They ran but were easy prey for soldiers.

THE FAMILY OF NOOR

The somber-faced 16-year-old stood silent in a narrow alley between two recently erected rows of huts at the Bangladesh-Burma border. Noor Muhammad did not have a hut. He's one of the younger survivors of the Aug 30, 2017 massacre in Tula Toli, a village on the border of Burma. He is alone. Noor says his mother and father were murdered, along with his four sisters and two brothers and their children. Almost half in any group of Rohingyas interviewed have witnessed a loved one being being killed by the Burmese mil-

itary, including children. A UN survey found that there 43,000 parents are missing, presumed dead.

HOW HASINA SURVIVED

wenty-year-old Hasina Begum fled south toward the Dual Toli river with her baby, to escape Burmese soldiers. Unfortunately, the rapidly flowing river was hard to cross and many of her neighbors who jumped in drowned. Soldiers caught the rest and began killing the men, and forced the women to stand in shoulder deep water.

Hasina was one of the women standing in the river. After hours of killing most of the men and throwing their corpses into a fire pit -- even those who were still alive -- the soldiers came for the women. Several soldiers dragged five women, including Hasina, to a hut. One snatched away her 16-month-old and threw the child into the fire. As they began ripping her clothes off to rape her, she resisted them and was hit and thrown into a hut, which was then set ablaze.



But she remembers only one blow, saying that she did not feel the ones that damaged her jaw. Finding a small opening in the burning hut, she escaped and hid in a vegetable patch. Late at night and without any clothing, she made her way to a nearby forest where other survivors clothed her.

IT IS GENOCIDE!

The UN first defined genocide in 1948 in The Genocide Convention. The treaty outlines that any of the acts committed with the intent to destroy, in whole or in part, a national, ethnical, racial, or religious group constitutes as genocide. Below are four conditions outlined in the treaty that apply to the Rohingya situation proving that Burma is indeed guilty of committing a genocide.

GENOCIDE: Targeting and Killing Members of the Group:

U.N. agencies, independent experts, and human rights organizations have reported the Myanmar Army has used lethal weapons against Rohingya in Rakhine State. Research suggest that 48,000 parents are missing. It is close to our estimate that about 100,000 Rohingyas have been killed.

GENOCIDE: Causing Serious Bodily or Mental Harm:

Rohingya women and girls are constantly subjected to rape by the Burmese Forces. Rape is used as a weapon to control and demean an entire village, as it often takes place inside mosques or in front of children, causing lifelong trauma. Torture is also used as a means to erase Rohingya identity.

GENOCIDE: Deliberately Inflicting Conditions to Bring About the Group's Physical Destruction in Whole or in Part:

Besides burning of 300 plus Rohingya villages, Rohingya are systemically denied medical care, sanitation, food, and paid labor opportunities. They have not been allowed in schools and have been banned from entering a mosque since 2012. Journalists and human rights organizations have described the IDP camps where 125,000 Rohingya are forced to live as "unlivable ghettos". Myanmar security forces have prevented Rohingya from leaving these camps.

GENOCIDE: Imposing Measures Intended to Prevent Births:

In 1993 & 2005, the Border Immigration Control Headquarters and the Township Peace and Development Council of Maungdaw issued population control policies that state the Rohingya population is reproducing faster than "international standards" of population increase. The authorities offered no evidence to support these claims. In order to get married, Rohingya acquire a permit which is rarely issued. Anyone marrying without it are subject to prison sentences of up to ten years. Rohingyas are not allowed to have more than 2 children.



WHAT DO ROHINGYAS WANT? 4 STRATEGIC DEMANDS BY BURMA TASK FORCE

ADOPTED IN A MEETING OF ROHINGYA LEADERS

1. Declare it is a genocide.

The Genocide treaty requires nations to interfere to stop a genocide and punish those who are responsible for it.

2. Rohingya must not be forced back to the genocide zone

without security and citizenship. Establish a UN defended safe zone in Burma as called for by the Bangladeshi prime minister.

3. Enforce strong and comprehensive sanctions

against the Burmese regime, excluding any sanctions on food and medicine, until the Government stops genocide, accepts safe zones, and restores Rohingya citizenship.

4. Continue aiding Bangladesh

to ensure the Rohingyas are treated as refugees with proper relief, education, and freedom of movement.



Burma has a population of about 50 million of which nearly 8 million are Muslims. Of the Muslim population, about 3.5 million (both at home and at the places of refuge) are Rohingyas of Arakan.

FACES OF HATE



ASHIN WIRATHU

TIME magazine described this Buddhist monk as "Face of Buddhist Terror." He labeled mosques as "enemy bases". The Burmese government has failed to effectively reign in his hate movement, allowing a ban on public preaching to expire, and never stopping him from traveling to Rakhine State or consorting with military groups. Up to now he has also used Facebook to spread his hatred of the Rohingya.

MONKS, MILITARY & SUU KYI ARE ALL TOGETHER!

Senior general of Myanmar armed forces walking with Suu Kyi. He led the genocidal operations calling it " left over business from World War II".







Rakhine or Rohang are the names of the same area previously called Arakan. It lies on the northwestern part of Burma with 360 miles coastal belt from the Bay of Bengal.

AUNG SAN SUU KYI Presiding over Rohingya Genocide

Suu Kyi, the leader of Burma, bowing down to the grand monk of Burma Sitagu Sayadaw who provided theological bases of killing non-Buddhists. He is Burma's most revered Buddhist leader. Addressing hundreds of officers at a military base in a live broadcast he asked soliders not to fear the sinfulness of taking human life. Sitagu Sayadaw has long made excuses for the military's abuses against Rohingya Muslims.

- Suu Kyi told CNN that she is a politician not a human rights defender.
- Suu Kyi is THE leader of Burma. She supports and does not condemn the genocide
- Suu Kyi and head of the armed forces Gen. Min Aung Hlaing could potentially face genocide charges in the future, said the United Nations human rights chief, Zeid Ra'ad Al Hussein.
- The City of Oxford has stripped her of a human rights award.
- Holocaust Memorial Museaum has stripped her of their award as well.
- There have been calls from her fellow Nobel laureates for her peace prize to be annulled.

The move caused the Dublin City Council to stripped Suu Kyi of her honor.

BURMA TASK FORCE HONORED MONKS WHO SAVED LIVES

Burma Task Force trained Burmese monks to stand up against hate in Burma. We also honored 3 monks who saved lives of 2,000 Burmese Muslims at the Nobel Peace Institute, Norway where Nobel Peace Prizes are given out.

he US House of Representative was the first elected body in the world which passed a resolution in support of Rohingya security and citizenship. Burma Task Force lobbied for Res. 418 and Res. 90.

We are now looking forward to the passage of Senate Bill 2060 as well as House Res. 4223. These bills ask the State Department to make a determination of genocide and crimes against humanity. They impose sanctions on Burma and allocate \$103 million additional dollars for Rohingya relief.
