Message from the Board Chair Dr. Khursheed Mallick

Assalam 'alaykum,

I am Dr. Khursheed Mallick, the Chair of the board of Justice For All. You may know me from my work on Indian Muslim issues and when I was the Treasurer of Bosnia Task Force. I am delighted at the growth of this dynamic organization – Justice For All – with offices in the US, Canada and the United Nations. Launching world-class projects such as the Save India From Fascism and now the Sri Lanka Task Force.

Justice For All has been a part of lawsuits against the Trump administration and for a couple of years have been communicating directly with presidential candidates and their policy staffers, including President Biden. 

This year we welcomed 3 new board members, Emad Al Turk, Ayesha K Mustafaa and Nusba Parveen. Each of our projects also currently have advisory boards consisting of predominantly impacted community members.

As an NGO with Consultative Status at the United Nations (Department of Global Communications), we participate regularly in the work of the United Nations through direct access to meetings, events and U.N. activities.

Assalam 'alaykum,

In the early 1990s, Sound Vision spearheaded the Bosnia Task Force. This was a broad-based campaign that built a coalition to advocate on behalf of Bosnia during the horrific war. Bosnia Task Force was instrumental in getting rape declared a war crime, working in partnership with the National Organization of Women (NOW). With the end of this tragedy, another began in Kosova, leading to the establishment of Kosova Task Force. That is when Sound Vision decided to formally establish Justice For All, broadening its commitment to stand up for Muslim human rights worldwide.

Year 2020 has been especially painful for the Ummah. The world's failure to stop the genocide in Burma has emboldened communists in China to create the largest concentration camps since Nazi Germany, where Uyghur Muslims are detained. And fascists in India are directing their attacks not just against Kashmir, but in the state of Assam, as well as targeting the country's 200 million Muslims.

God controls the world. We don't. But when we come to know about injustice, it becomes our responsibility to stop it. This has been the mission of Justice For All from its start in the 1990s, when we spoke up for Muslims in Bosnia. It remains so today: equity, justice, fairness for all.

Message from Director DC Operations - Hena Zuberi

Dear Sisters and Brothers,

Assalam alaykum,

This is Hena Zuberi.

I do believe Justice work is worship. It is a commitment to God that we will do what we can to be an Ambassador of Allah and bring God-consciousness, fairness, equity, justice, peace, equality and balance in all our dealings. This is a Quranic concept that stresses the doing of what is right because it is the truth. This work is truly needed as human life and especially Muslim life has been devalued by genocide and persecution from Burma to CAR (Central African Republic) to East Turkestan.

I joined Justice For All's work as volunteer for the Burma Task Force many years ago. I started working here full time as the Director of Outreach for the Capitol region in 2017, lead advocacy on the hill for the Rohingya cause, was the team lead for the Save Uighur Campaign until we hired Aydin Anwar, a Uyghur activist to lead the team. Currently, I help coordinate our projects and conduct national advocacy work in Washington D.C. as the Director of the DC Office.

Justice For All is currently funded exclusively through grassroots donations from the American Muslim community and allies. We do not accept any government funding.

In 2020, due to the COVID-19 pandemic, we lost a large percent of our projected funding. We have slashed expenses and worked harder and smarter with very few resources.

We urgently require strong continued financial support to continue this work, especially as we are confronting powerful nations that maintain their hold on power through divisive policies including attacking their Muslim minorities.

We work to strengthen a movement of "people power," coordinating and strengthening partnerships to attain goals- self determination, peaceful repatriation and restoration of all rights.

Our Mission, Goals & Priorities

Justice For All is committed to redoubling its efforts, including involving our network of American imams and community leaders, to call on our nation's leadership to stand up against genocide and support human rights especially for oppressed Muslim minorities in America and across the world.

As a faith based human rights organization, we believe in the establishment of "qist"- a Quranic value of equity, fairness and justice. This cannot be achieved until the most vulnerable in a society find security and justice.

Justice for All aims to address the rising Islamophobia around the world which impacts us directly as Muslim Americans, and also leads to harmful policies and persecutions abroad. We strongly encourage a sense of inclusive global citizenship among our constituents. Justice for All has worked to raise awareness of a range of human rights concerns impacting vulnerable minority groups. We also have a consultative Status at the United Nations and staff who advocate for our cause.

In past years, Justice for All has addressed mass persecution in the Central African Republic and mass displacement in Mali. In addition to its focus on Rohingya Muslims in Burma, Justice For All works to educate and stop the genocide of Uyghur and other Turkic minorities by the Chinese Communist Party. The work we do is crucial to those who are suffering. It is only with your generous support that we can keep up with the work we do every day.

We have met with hundreds of Congressional offices about the persecution of Muslims in India, Kashmir, Burma and East Turkestan. We also were able to bring the Uyghur cause to the attention of millions including the Vice President of the United States Mike Pence, and were instrumental in getting the Uyghur Human Rights Policy Act passed into law.

Your donations also help us make advocacy easier for Muslims with our 'Call and Email Congress' tool on our websites. And it is with YOUR help that we were able to gather the testimony of Rohingya genocide survivors to file a case in the international court against Burma for its war crimes and genocide.

We have two TV shows on the subject of Peace and Justice on Muslim Network TV. These shows are aimed at giving marginalized minorities an active voice and a chance at telling their stories. Our aim is to highlight these individuals and communities whose voices are so often overlooked by the mainstream media.

NextGen Training

In collaboration with Sound Vision's training programs, Justice For All trains the next generation of advocates and activists to establish Qist. This is done under an Islamic human rights framework, guided by the Mercy To Mankind in his Prophetic call and based on the Quran. Our leaders must be trained to be purveyors of justice without compromising their values.

Trainings include: organizing, mobilizing, lobbying, coalition building, media and spokesperson on camera workshops, fundraising techniques, time management, team building, self reflection, learning from seasoned activists and Islamic scholars.

In 2019, we held the first training in an idyllic location outside Chicago. From Fajr, morning prayers to Isha, night prayers for 5 days, our fellows spent time learning and reflecting. We have trained over 30 fellows, many from impacted communities, who have gone on to form their own initiatives, some have become advisory board members for our different projects, others work for Muslim advocacy organizations.

Justice For All 2020

Justice For All comprises of four main projects that we focus on throughout the year. Under this umbrella we have Burma Task Force, Free Kashmir Action, Save Uyghur Campaign and Save India From Fascism. Each of these projects have their own team leads and goals for the year. Our projects operate independently of each other but are united in our goal to achieve Justice for Muslim minorities, indigenous people and Muslims in occupied regions across the world.

Justice for All staff meets with UN leaders and experts on a regular basis, urging them to confront mass atrocities and to take effective action on the Rohingya and Uyghur crises. Staff also regularly consults with other human rights organizations active at the UN, to build consensus and strategize around Migrant and Refugee Rights, Trafficking, Xenophobia, Disinformation, Genocide Prevention and SDG 16 (Human Rights). In January 2020 we joined our allies in the Hague, attending the Rohingya genocide case at the International Criminal Court and celebrated the initial outcomes. In March, we were able to personally confront the Chinese Ambassador at the United Nations, and we continue to work to deepen relations between minority groups persecuted by his government. Despite limited access due to the pandemic, we continue to speak directly to numerous ambassadors, and work to hold the system accountable; for example, in December, we sent letters of concern on disinformation by fake NGOs covering up atrocities in Kashmir and violence against Indian minorities.

At the Nation's Capitol, we honored the Gambian Minister of Justice Abubacarr Tambadou in an event that brought together over 400 lovers of justice just before the pandemic. In attendance were ambassadors, dignitaries, religious leadership, interfaith friends, the Gambian community, Muslim community leaders, human rights activists and advocates for the Rohingya people. We honored His Excellency the Attorney General Abubacarr Tambadou for his courage in taking the case against Burma to the International Court of Justice- the world's highest court. He won the case as the court recognized the Rohingya genocide and issued provisional orders to Burma. He was awarded our Torch of Justice Award. Imam Omar Suleiman presented the award on behalf of American Muslims.

Arselan Suleman, the human right attorney working on the court case was awarded the Burma Task Force Advocate Of The Year. This award was previously given to Imam Magid (former head of ISNA) in 2019.

A proclamation signed by 100 Muslim leaders was presented to His Excellency Minister Tambadou for his bold decision to take the Burmese regime to the international Court of Justice.

When the pandemic hit, Justice For All jumped into action using our educational and advocacy tools to pressure the government to issue Protective Personal Equipment to our healthcare workers through a targeted campaign. We collaborated with a supplier to help under-served communities get PPE.

This Ramadan we launched our Justice in Ramadan: Qist Conference, featuring Congressman Joe Wilson and US Commission on International Religious Freedom (USCIRF) Commissioners, an event attended by hundreds of advocates. Our #LoveUmmah events focusing on the fighting the oppression of our Ummah resonated and brought hope to many impacted people.

Justice for All members also spoke in several important conferences, including ISNA, Amnesty International's Annual General Meeting, the Annual Ministerial of International Religious Freedom and partnerships with Yale, NYU and other student activist groups.

Prior to the US elections, we ran a successful educational campaign on each one of our causes and succeeded in connecting constituents to every candidate running for election in their state for Congress, Senate or the Governor's position.

This year, our side event at the Ministerials, Islamophobia Leads To Genocide: A Case of Burma, China, India and Kashmir, was attended by dignitaries and supporters from around the world and covered in international media.

In November, our Islamophobia in Three Asian Context Report: China, Burma and India was filed with the Special Rapporteur on Freedom of Religion or Belief Office of the United Nations High Commissioner for Human Rights, in preparation for the report to the 46th Session of Human Rights Council.

In early December, we released a human rights agenda and a detailed set of recommendations for the Biden administration covering foreign and domestic policies.

In 2021, we plan to activate local groups and student groups so look out for an affiliated chapter in your state.

Targeted Approach

Our work is not limited to just influencing governmental policy. Although we regularly do work with Congress and governmental bodies to implement effective change, we also focus particularly on the following items:

Education

This is KEY to our success. We work within our communities to provide quality education on issues affecting the diaspora and minorities. This the first step to having effective change, making people aware of what is going on. Our outreach team has also conducted several advocacy training for community members.

We work to mobilize our communities in an effective way by bringing them together in different ways. One way is that we focus on organizing rallies, demonstrations and protests across many states.



We monitor media reports and correct language that negatively affects the people we are advocating for. We have two shows on Muslim Network TV dedicated to educating a wider audience on our concerns. We maintain active social media accounts on Twitter, Instagram and Facebook to make sure that we can reach multiple generations of people. We also have had Op Eds in several prestigious newspapers.

Coalition Building

We work with Interfaith partners to achieve shared goals and reach out to diverse human rights, social justice and advocacy activists.

At our core, we believe God says that all Prophets of God were sent to establish peace, fairness, and socio-economic justice in this world. We are inspired by our faith and shared values and principles with allies to work locally on a grassroots level to educate, advocate and locally mobilize Americans to end human rights abuses of all minorities.

Our aim is to inspire our neighbours and community members to demand policies that protect human rights and support humanitarian aid for victims of religious persecution. JFA grew out of the dire need for advocacy efforts highlighting the ethnic cleansing campaign by Serbian forces, and gross human rights abuses experienced by the ethnic Muslim minority in Bosnia (Bosniaks), and later Kosovo. Decades later, we are committed to building an inclusive community of American Muslims, multi-faith allies, and supporters of all backgrounds to ensure that in today's world, justice for all is a God-given right and "justice for some" is not acceptable.





BURMA TASK FORCE

Burma Task Force has worked since 2012 to mobilize support for the persecuted Rohingya Muslim minority of Burma (Myanmar). Though a Burmese anti-Muslim movement had been gaining strength in recent years, this human rights crisis came most dramatically to the world's attention three years ago when hundreds of Rohingya villages were attacked by the Burmese army and over 750,000 Rohingya men, women and children fled into Bangladesh.

As the Burmese military increasingly embraced genocide, mass rape, land-grabbing and displacement, our NGO has worked to bring together leaders from the impacted community and policymakers, pushing for stronger sanctions against the Burmese government, supporting formal genocide determinations, international justice, humanitarian aid, and full restoration of rights to the Rohingya. We have had some success in all these areas, except the last. While the Burmese government resists compliance with international laws, we face a major challenge with many dimensions.

Burma Task Force engages regularly with influential officials in US Congress, State Department and the White House, and also in the United Nations, and to keep momentum have coordinated with leaders and civil society in certain nations (including Canada and some EU nations) that have taken a special interest in this human rights disaster.

In 2018 and 2019 our successful Advocacy Days in Washington D.C, brought over 300 of us into the offices of hundreds of lawmakers and convened numerous refugee leaders from Burma to encourage solidarity and cooperation among diverse persecuted minorities in Burma. Without such solidarity, it is unlikely that the Rohingya will ever be accepted and included in Burma. Without such continued pressure on Congress, now via online meetings, the issue will be sidelined. As it is, the House of Representatives voted to call the situation a genocide in December 2018. The Republican National Committee and the Canadian Government have also made the same determination. We will pressure the next administration to do more.



Fighting at the International Courts

We retained barristers at the International Criminal Court to further develop a case against Burmese government; collected and translated 160 personal testimonies from Rohingya victims of atrocities; and filed a civil lawsuit against the Burmese government. Earlier this year, we celebrated the first successes of the International Court of Justice (ICJ) both in the Hague and in our own events for the lawyers involved in the case. But this long process is not complete and if Rohingya are really going to have justice we need to confront Burma's evasions and lack of transparency. We flew Rohingya leaders and allies from the United States and Canada to the Hague to witness the historic case and sat in strategy sessions with the team.

Media Work

We funded two prize-winning documentaries that aired on national cable news outlets like CNN. A strong Burma program will be able to support strong reporting. Media rapid response helped stop attacks against Rohingya on 4 occasions.

Analysis

During the last few years, Burma Task Force has drafted "white papers" for use by policymakers in Congress and at the State Department, including five 2020 studies relating to Burma's lack of compliance with the ICJ rulings noted above. Policymakers have expressed appreciation and we need sufficient staff to be able to continue.

Advocacy

As the sole entity working on the Burma/Rohingya issue to have retained lobbying & PR firms on these matters, we need to continue to have bipartisan "insiders" on our team, especially at a time of great political polarization. They have helped mobilize evangelical Christians to sign statements of support, with the latest statement on Burma issued by the influential Southern Baptist leadership in August 2020. At the UN, we have met over 35 times with the presidents of the UN Security Council and spoken on panels. We have consulted several times with the Special Envoy, the Special Rapporteur, the Special Fact-Finding Mission and with UN Mission staff, refugee agencies and other experts. We hope to continue to keep the Rohingya issue alive at the UN, despite the challenges ahead.

Education

We must continue our essential role of raising awareness through Action Alerts and extensive social media work, to involve young people in defending human rights. We plan to continue expanding online television programming as well as promoting Rohingya and Burmese ethnic speakers, encouraging essay contests and other initiatives.

Partnership Building

We emphasize our interfaith efforts on behalf of religious freedom, our regular participation in the International Religious Freedom Roundtable, close coordination with US Commission on International Religious Freedom, and the US Holocaust Memorial Museum, as well as Jewish and Muslim leaders. We help mobilize diverse faith communities. We have trained Buddhist monks and other faith leaders to act on behalf of the Rohingya; and in 2019, trained diverse Burmese youth to be peacemakers and organizers and improve leadership skills. We seek to continue this important role.

On humanitarian aid, last year the US Congress voted to provide \$400 million in aid and Canada to provide \$300 million. With the economic impact of the global pandemic we will have to make a major push this year to keep these funding levels.

We also engage with Bangladeshi officials in conferences, in media, at the UN and elsewhere, to encourage continued support of the refugees and an end to harsh restrictions on their camps. The Bangladesh government recently agreed to lift internet restrictions on these camps. Free and full communications are especially important during the pandemic.

Our Letter signed by 120 North American imams and leaders to the Bangladesh Foreign Minister on the relocation of the Rohingya refugees to was covered by one of Bangladesh's English daily. Taking advantage of the new technologies during the pandemic, Burma Task Force is an integral part of the online television programming produced by Justice for All. In addition, we have produced several online panel discussions this year, including an all-day conference with 20 expert speakers, a rally against genocide with a similar number of speakers from around the globe, and a Burma leaders' round table.

SAVE UIGHUR CAMPAIGN

This year was a powerhouse of a year for Uyghur advocacy. Getting the language of Uyghur genocide into the American lexicon was no mean feat but we were able to accomplish this and much more.

After a year long campaign, we forced MIT to end ties with a Chinese surveillance firm, United Nations: For the first time in history, the Chinese Ambassador to the United Nations at the United Nations was confronted on the issue of missing Uyghurs by a Uyghur advocate - our Save Uyghur Campaign lead Aydin Anwar. Our staff at the United Nations attended meetings to engage in meaningful civil society engagement in UN processes.

FREE KASHMIR ACTION

This past year, the people of the Indian Occupied Jammu and Kashmir have suffered most grievously. On August 5th, 900,000 Indian occupation forces invaded Kashmir and re-occupied it. Ever since then, India has been brutalizing the people and colonizing the territory by the way of persecution as well as enforcement of new laws of registration, domicile and land sale.

The scale at which these atrocities are being committed have been rightly termed as genocide, crimes against humanity and war crimes. Kashmiris are being exterminated; they are being made aliens in their own land, homeless in their homeland. Since then, Justice for All has established a full-fledged department, Kashmir Action.

We have continuously published newsletters, in order to increase education about the Kashmir issue. 75,000 printed booklets were distributed through a well-planned and effective material distribution network. Our daily and then weekly actions published on the Free Kashmir website and sent out to our volunteers brought thousands of actions on the Kashmir cause. The Kashmir hearings on Capitol Hill were amplifies through our channels.

On July 25th, 2020 our global DIGITAL RALLY FOR KASHMIR and Twitter storm was held, which was addressed by renowned speakers from Indian occupied Kashmir, Azad Kashmir, UK and USA and broadcast through satellite to US, Canada and Mexico.

Before the rally, a Jumuah khutbah campaign was initiated. Many mosques and Islamic centers in the US and Canada dedicated their khutbah to the Kashmir cause.

We have worked with coalition partners in DC and New York on Kashmir.

This includes the history of Kashmir related to suppression of voices of freedom and history of massacres in Kashmir, life and contribution of reputed Kashmiri leaders on our FreeKashmir.org website. Future programs also include video interviews from impacted people from Kashmir and prisoner profiles. Moreover, Kashmir Action has planned an Advocacy Day, district meetings with Congress people on Kashmir, meeting with Kashmiri organizations to discuss ways to cooperate and collaborate in different common projects and outreach to those who do not know about Kashmir and to those who are friendly with Kashmiris. Our Qist conference featured Kashmiri scholars and allies. Through our consistent outreach teams and collaboration with interfaith and human rights organizations and international civil society, we have an unwavering resolve to continue with our struggle until the people of Kashmir are freed from occupation of India, Insha Allah (God willing). Justice for All Film Series launched in 2020 and the first of the series "Tales of Siege" was shown on November 6, 2020. We hosted the film with a facilitated discussion. A tool-kit was published for allies to replicate the screening of the film in their own circles.

Our Twitter storm campaign #FreeKashmir on August 5th to condemn nefarious actions of Indian government against Kashmiris reached 142,000 people. The Indian government has been deceptively propagating about their claims of 'exciting developments' since abrogation of article 370. Kashmir Action published a strong rebuttal titled, Pedalling Backward, exposing their claims of development and progress in JK and we organized a social media campaign against new domicile laws in Kashmir. Using our show Justice For All Now, we have highlighted several Kashmiri voices.

SAVE INDIA FROM FASCISM

Justice For All (JFA) began its Save India project to make Americans and American lawmakers aware of human rights atrocities perpetrated against minorities in India. Our work has made lawmakers cognizant of India's disturbing trajectory towards fascism, which is against human conscience and also against US values.

Currently, Genocide Watch had issued two Genocide alerts to India. In 2020, the United States Commission on International Religious Freedom (USCIRF) has urged the Department of State to place India among the worst violators of religious freedom in the world.



- 30+ Meetings with Senate and Congressional offices on India on the state of Muslims and Christians and RSS infiltration in the United States
- Researched and submitted 36+ victims and prisoners of conscience detailed reports to USCIRF.
- Weekly Meeting with Ambassador Brownback and the IRF India Working Group
- Arranged meetings with the office of Vice President Pence to brief on India.
- Submitted policy recommendations to Pres. Trump's office on India
- Connected with mainstream organizations and the Biden campaign in educating on RSS and fielded candidates in Nov. elections



JFA has worked on several campaigns to pressure India to halt its hateful Hindutva agenda against religious minorities and urged the lawmakers to oppose India's discriminatory legislative tactics, like the passage of the Citizenship Amendment Act (CAA), which offers citizenship to all religious minorities from surrounding countries except Muslims, and the National Register of Citizens (NRC). In the past year, our Save India team has been working on various initiatives. We mobilized the American Muslim community and were on the streets with allies during PM Modi's visit to the United States and to protest the CAA in January of 2020.

Justice for All is part of several coalitions on anti-genocide, human rights and religious freedom in India, which include weekly and monthly strategy sessions with other organizations to strengthen our cause.

One of our most significant achievements include arranging a meeting with the office of VP Pence to brief on India. Even through this polarized Congress, we submitted policy recommendations to Pres. Trump's office on India and gave regular updates to the State Department regarding human rights and religious freedom in India. We were part of the effort to get 12 Senators send a letter on India's CPC designation.

We have worked with the State Department to arrange a meeting with Asst. Sec. Alice Wells, Bureau of South Asian affairs, for several organizations working on India issues. We made sure to provide weekly updates on oppression of Muslims and minorities in India. We have also assisted in making policy and report recommendations and updates on minority suppression. We stood with human rights watchdog, Amnesty India, as its offices were shut this year and conducted media monitoring and correction of narrative of Delhi pogram.

Our Save India from Facism team accomplished a number of things just in the month of December. This shows that not only is our team extremely dedicated but we are grateful for having a talented team and, please know that this has been due to your help. × Congressional Outreach

Justice for All has taken part, this year in important congressional outreach programs. We have had several email campaigns and calling congress campaigns on India. This allowed us to be in regular contact with Foreign Affairs staffers on issues related to India, specifically.

We also conducted outreach to Senate offices on Senator Lankford's letter, encouraging other Senators to sign. This resulted in 14 Senators co-signing the letter on submission to the State Department. We were in talks with several offices on draft resolutions discussed with lawmakers in Congress. Finally, we submitted a rebuttal to a Indian government's biased memo on Kashmir as well as NRC/CAA. Our team has been able to do this, through your support and donations

× Save India, United Nations and USCIRF

Justice for All, has a consultative Status at the United Nations. This allows for important dialogue at different levels. We have facilitated and connected activists with key persons at the Office of the High Commissioner for Human Rights. We have a relationship with USCIRF (United States Commission on International Religious Freedom) and were able to arrange webinars with commissioners to educate the community on USCIRF workings and focus. We also worked with USCIRF commissioners to add language of interest in USCIRF letters. We have filed cases for prisoners with the commission including Father Stan Swamy who was listed on USCIRF's victims list- this is the only prisoner listed from India.

× Educational and Social Media

Until the pandemic slowed us down, the Save India campaign had distributed ten of thousands of printed booklets around the country on the rise of fascism in India. We have had meetings in many cities educating communities on the topic.

Archived Research compilation on our Justice For All: this research will be helpful for those interested in learning further on India. Permanent storage of material that has been collected from various sources on different issues affecting Indian minorities. We have regular campaigns on Instagram and Twitter to engage young activists as well as politicians on current issues.

Muslim Network TV Shows

'Justice For All Now' is a television show, hosted by our Director DC and journalist Hena Zuberi, which live streams on social media and YouTube, in which we focus on discussing various issues pertaining to peace, justice, human rights, and civil rights. She conducts in-depth interviews with people on the front line of the world's most pressing issues. Grassroot activists, scholars and community workers are highlighted along with celebrated activists.



Women in Justice is a special series in the show that covers the lives of women who have dedicated their lives to justice work, from lawyers to domestic violence advocates to anti-war giants like Medea Benjamin. Over a hundred shows were broadcast in 2020. On 'Justice For All Now', you'll hear a diversity of voices and analysis on establishing justice the world over.

UN This Week

Currently, Justice For All produces weekly programming with a range of guest speakers appearing on the "UN This Week" program, hosted by our UN Program Director Adem Carroll. We discuss topics such as nuclear disarmament, climate change, religious freedom, Islamophobia and refugee protection, peacemaking, the role of civil society at the UN, the nature of international human rights law and courts, protecting digital rights and the impact of counter-terrorism on charities,



and many more issues. These shows could serve as preparation for students considering a career in international affairs, or be of interest to anyone wishing to be an informed global citizen.

'Justice For All Now' and 'UN This Week' are broadcast on Muslim Network TV, a newly established North American television network aimed at a primarily Muslim audience in which we seek to educate and empower the broader American Muslim community. Muslim Network TV currently broadcasts to the US, Canada, and Mexico on Galaxy 19, Roku TV, and Amazon Fire TV.

JUSTICE FOR ALL SPONSORED DOCUMENTARIES

In 2020, Justice For All started the JFA Film series. This is a program of screening documentaries with tool kits for facilitated discussions. These toolkits can be shared with allies so they can host their own screenings.

Justice For All has funded several documentaries which have won prestigious awards and appeared on CNN, BBC and others. Justice For All sponsored the award-winning director Jeanne Hallacy's film MOTHER, DAUGHTER, SISTER, which exposes the Burmese military's practice of using rape as a weapon of war. The film details the stories of Kachin and Rohingya activists, including Shamima, a volunteer counselor working with survivors of military rape, Dil Kayas, a teenage survivor, and San Lung and Lu Ra, the sister and mother of two school teachers brutally raped and killed in 2015. Powerful testimonies from these survivors, witnesses, and activists explore the far-reaching impact of sexual violence and trauma upon their communities, and together, the women call for justice and an end to the army's impunity. Genocide Exhibit at Holocaust Memorial Center

In February 2020, the Islamic Center of Long Island in Westbury, New York and Holocaust Memorial and Tolerance Center of Nassau County in collaboration with Justice For All opened a joint exhibit called Never Again is Happening Again: The Persecution of Muslims in Asia. In the inaugural program launching the exhibit, keynote speakers Imam Abdul Malik Mujahid and U.S. Rep. Tom Suozzi emphasized the need

for educating America on these issues

The chairman of the center, Steven Markowitz, stated "What is going on in Western China, India, Kashmir, and Myanmar (Burma) — where there is state-sponsored genocide, racial purity laws, concentration camps, and exclusion of people from society, their jobs, their livelihood, and schools simply because they are Muslim — is no different than what the Jews experienced in Germany and other parts of Europe during [World War II]"



The Holocaust Memorial and Tolerance Center of Nassau County is the preeminent Holocaust resource on Long Island, New York and the Islamic Center is the largest Masjid in the area.


