In Canada,


We expanded our team to 5 major cities: Toronto, Ottawa, Vancouver, Edmonton and Calgary with a strong volunteer base in London, Ontario.

★ Bearing Witness: Delegation Visit to Rohingya Camps



Justice For All's delegation to the Rohingya refugee camps was a powerful testament to our unwavering commitment to justice and human dignity. Stepping into the world's largest refugee settlement in Cox's Bazar, our team bore witness to the harrowing realities faced by a people who have endured unimaginable atrocities.

Through direct engagement with survivors, community leaders, and humanitarian workers, we documented firsthand accounts of resilience amidst despair. These stories, often silenced by global indifference, now serve as critical evidence in our advocacy for justice and accountability on the international stage.

The delegation's visit also reinforced our resolve to demand meaningful action. By amplifying the voices of Rohingya refugees, we are pushing for stronger policies in the U.S. and Canadian governments, urging them to uphold human rights and support sustainable solutions.

This mission was not just about bearing witness—it was about standing in solidarity, speaking truth to power, and reminding the world that the Rohingya's struggle for justice is far from over. Together, we will continue to fight for their right to live with dignity, safety, and hope.



★ Pursuing Accountability and Justice at the International Criminal Court

13,000 children killed by Israel in Gaza Genocide

13-year-old Nahedh and his brother Ramez Barbakh were shot to death by Israeli snipers while carrying a white flag.

Hind Rajab, 6 year old, her four cousins, her aunt and uncle, and the two paramedics who came to her rescue were killed by Israeli soldiers.

Israeli forces killed a **12-year-old Dunia Abu Mohsen** while she was hospitalized from losing her leg in an Israeli airstrike that killed her parents and siblings.

Justice For All filed their cases at the International Criminal Court



In North America, Justice For All has been at the forefront of this struggle for justice. Our Committee on ICC Submissions has filed **36** cases, meticulously documenting the following war crimes:

- *The bombing of medical facilities, including hospitals and ambulances.*
- *The deliberate targeting of civilians, especially children.*
- *The use of white phosphorus and other illegal weapons in densely populated areas.*
- *The destruction of homes, schools, and places of worship.*
- *The siege on Gaza, leading to mass starvation and lack of medical care.*

In addition, our Family Toolkit, designed to empower families to document war crimes and file cases, has been downloaded **12,569** times. This shows how deeply our work resonates with those directly impacted by these heinous acts.

While this announcement by the ICC is a meaningful milestone, the fight is far from over.

★ Torch of Justice Award: Honoring South Africa and Dr. Naledi Pandor

Each year, Justice For All bestows its highest honor, the **Torch of Justice Award**, upon those who exemplify extraordinary dedication to human rights. In 2024, this prestigious award was presented to South Africa and **Dr. Naledi Pandor**, a fearless advocate who played a pivotal role in bringing Israel to the International Court of Justice, amplifying the call for accountability for its actions in Palestine.

Maryland: On the evening of Thursday, April 13, the Gaithersburg Marriott Washingtonian Center in Maryland became a vibrant symbol of solidarity and support for human rights. Hosting 300 dedicated attendees, including allies, activists, and supporters, the ballroom was adorned with the flags of South Africa and Palestine, creating a powerful display of unity and shared commitment.

This special gathering, organized by Justice For All, was held to honor the Government of South Africa for its steadfast legal advocacy for Palestine. After thorough vetting of Justice For All's credentials and impact, the Government of South Africa officially accepted the Torch of Justice Award, enhancing the event's significance and celebrating a shared dedication to global human rights.

Chicago: On September 14, 2024, nearly 700 gathered in Chicago to celebrate Dr. Pandor's impact on global justice. Leaders from Muslim organizations joined in presenting her award.



Honoring the only world leader who dared to sue Israel for genocide in Palestine

Dr Pandor. served as South Africa's former Minister of International Relations and Cooperation from 2019-2024. She was the lead of the ministerial team of the cabinet of South Africa that initiated the genocide case against Israel at the International Court of Justice.

Dr Pandor. was appointed the new Chair of the Nelson Mandela Foundation in October 2024. Dr Pandor. will be the third person to hold the position since Nelson Mandela established the organization in 1999.

Dr Pandor. became an MP in 1994 and has amassed impressive experience in positions of public office, including Deputy chief whip of the ANC in the National Assembly from 1995 to 1998, served as the Deputy chairperson of the National Council of Provinces in 1998, and its Chairperson from 1999-2004.

Dr Pandor's. experience in education policy planning made her a welcome appointment as South Africa's Minister of Education in 2004. She has been a member of cabinet ever since, and has served her country in the following portfolios:

Minister of Home Affairs (2012-2014); **Minister of Science and Technology** (2014-2018) and **Minister of Higher Education and Training** (2018-19).



Advocate of the Year: Honoring Dr. Adam Hamawy and PAMA

This year, the Advocate of the Year Award was presented to PAMA (Palestinian American Medical Association) in recognition of their tireless efforts to provide critical medical care in Gaza amidst immense challenges. The award was received by Dr. Adam Hamawy, whose unwavering dedication became a symbol of selfless service.



Dr. Hamawy, who famously refused to leave Gaza during its most harrowing moments, exemplified the spirit of true advocacy. Speaking to a major news outlet while in Gaza, he said:

“As a doctor, my duty is to stand by my patients, even in the darkest of times. The world cannot afford to look away from Gaza—it is our collective responsibility to save lives and bring hope.”

Justice For All played a key role in advocating for Dr. Hamawy's safe return, highlighting his heroism and commitment to his patients and teammates under dire circumstances. We are honored to recognize PAMA and Dr. Hamawy for their extraordinary contributions to humanity and justice.

★ Palestine Media Watch: Amplifying Truth, Confronting Bias

Palestine Media Watch is Justice For All's dedicated initiative to counter misinformation, challenge biased narratives, and elevate the voices of Palestinians in their struggle for justice and self-determination. Through strategic media monitoring, targeted training, and impactful advocacy, PMW equips communities with the tools to critically analyze media, respond effectively, and advocate for balanced coverage.

In 2024, Palestine Media Watch:

- Trained **over 750+ individuals** in media literacy and advocacy.
- Engaged **750+** media outlets
- Produced **infographics and multimedia campaigns** reaching thousands, inspiring action and solidarity worldwide.

Key Achievements:

- “Created the **Palestine Media Guide**, updated daily, to provide accurate and balanced information for media engagement.”
- “Engaged with hundreds of thousands of media narratives through strategic monitoring and responses, using advanced tools like **Meltwater**, a platform employed by mega-corporations.”
- “Built a team of six dedicated staff who monitor media, issue alerts, and maintain a dynamic database of responses.”

★ Children of Palestine Advocacy Day: A Testament to Justice for All's Impact



The Advocacy Day, an exciting opportunity, inspired me to contact my congresspeople and representatives and use my power as a constituent to create real change to help Palestinian children.

On April 17, 2024, Justice for All hosted the Children of Palestine Advocacy Day on Capitol Hill, uniting advocates from across the nation to demand action for Palestinian children. Armed with a powerful memo outlining critical demands—including a ceasefire, the release of child prisoners, and robust efforts to rebuild Gaza—we visited Congressional offices to ensure policymakers heard our collective call for justice.

Our approach went beyond the immediate goal of a ceasefire; we pushed for long-term solutions to restore the lives and futures of children in Gaza. The inclusion of Girl Scout troops and youth leaders from multiple states highlighted the intergenerational commitment to this cause, inspiring lawmakers to recognize the urgency of rebuilding Gaza and protecting Palestinian children.

While the ceasefire tragically came too late for thousands of innocent lives, we acknowledged the genocide and demanded accountability and justice. In an unfriendly political environment, our youth advocates rose to the challenge, embodying the spirit of qist (justice) as exemplified by Musa (AS), who stood firm against Pharaoh, even when his voice shook. Their courage and resilience in the face of indifference and hostility showed the strength of their conviction and the power of advocacy rooted in faith and justice.



As rebuilding efforts begin, our advocacy demonstrates that even in the most challenging circumstances, our voices can spark action. To our donors: this progress is your success, proof that standing firm for justice—even in adversity—can lead to real change. Together, we are building a world where justice prevails for every child.

★ NextGen Training: Empowering Tomorrow's Justice Advocate

Justice For All's **NextGen Training** in collaboration with SoundVision is a transformative program designed to equip and empower the next generation of human rights champions. Drawing inspiration from successful models in the U.S., this initiative fosters a deep understanding of justice work while providing practical tools for advocacy.

In 2024, a 4 day intensive **NextGen Training** was held at the Diyanet Center of America with 35 participants. We also launched a one day training in **Chicago**, offering a comprehensive, multi-session curriculum that engaged **36 participants**. Participants delved into critical subjects such as effective media advocacy, engaging with policymakers, and addressing systemic injustices. The feedback has been overwhelmingly positive, with participants expressing gratitude for the opportunity to learn, grow, and take actionable steps in social justice advocacy. One attendee shared so I can grasp ideas for my future.

★ Burma Task Force

Success Highlight:

ICC Pursues Justice: Arrest Warrant Sought for Burma's Commander-in-Chief Min Aung Hlaing for Crimes Against Humanity, Including Deportation and Persecution of the Rohingya.



Surveying Rohingya Women: Voices from Kutupalong



In December 2024, Justice For All conducted a landmark survey of **1,000 Rohingya women** in the Kutupalong refugee camp—among the largest of its kind. This ground level initiative focused on capturing the lived realities of women after seven years in the camps, with a deep dive into critical areas: **education, health, and safety**.

Our dedicated staff on the ground worked tirelessly to ensure the voices of these women were heard and their experiences documented. The survey unearthed key insights into the challenges they face daily, from inadequate access to healthcare and educational opportunities to the constant threat of insecurity in the camps.

This invaluable data is being compiled into a comprehensive report, set to be released in **2025**, which will provide policymakers, humanitarian organizations, and the global community with actionable recommendations to address the urgent needs of Rohingya women and advocate for sustainable solutions.

Through this initiative, we aim to amplify the voices of Rohingya women, ensuring their stories catalyze meaningful change and serve as a rallying cry for justice and accountability.

★ Save India From Fascism

Recognized Leadership:

Co-Chair of the International Religious Freedom Roundtable on India, ensuring minority voices are prioritized in global discourse.

Justice For All's Save India from Fascism campaign continues to be a critical force in exposing human rights violations and advocating for the protection of India's marginalized Muslim communities. Through strategic advocacy, coalition-building, and media engagement, we have worked tirelessly to bring global attention to the escalating repression faced by minorities under rising authoritarianism in India.

In 2024, our efforts have led to significant milestones, including:

International Advocacy: Submitted a comprehensive review to the Human Rights Committee (ICCPR) and provided witness testimony to the Tom Lantos Human Rights Commission, shedding light on India's transnational repression of dissidents.

Policy Engagement: Engaged with key stakeholders, including the FBI and U.S. Senators, to address India's expanding repression tactics beyond its borders.

Media and Public Awareness: Delivered a groundbreaking report on the stance of Muslim Indian film actors to international journalists, raising awareness on the systemic silencing of cultural figures.

Community Mobilization: Led impactful campaigns urging Muslim majority countries to respond to attacks on foreign students in India and collaborated with diverse organizations in Montgomery County, MD to amplify our message.

Advocacy Actions: Submitted an official protest to the U.S. State Department, calling for the designation of India as a Country of Particular Concern (CPC). Additionally, we have taken a vital step in preserving the history and struggles of India's Muslim minority by launching a digitization and archiving project for community journals.

Through education, advocacy, and persistent engagement, Justice For All remains dedicated to challenging oppression and holding the Indian government accountable for its human rights abuses. With your continued support, we will push for justice and protection for India's vulnerable communities.

* Save Uyghur Campaign

Recognized Leadership:

Elected to exclusive Steering Committee of End Uyghur Forced Labor Coalition- the prime coalition working on ending Uyghur slave labor in businesses

END UYGHUR GENOCIDE

Throughout 2024, Justice For All's Save Uyghur Campaign has tirelessly advocated for the Uyghur community, confronting alarming human rights abuses and highlighting the urgent plight of Uyghur asylum seekers worldwide.

Save Uyghur commemorated several significant anniversaries, including the 34th Anniversary of the Baren Massacre April 5, the 15th Anniversary of the July 5th Urumchi Massacre, and the 10th Anniversary of the July 28th Yarkand Massacre. These memorials serve as powerful reminders of past tragedies and reinforce the Save Uyghur Campaign's resolve to prevent future atrocities.

In April, Save Uyghur supported UN experts in urging the Thai government to expedite the resettlement of Uyghurs who have faced over a decade of arbitrary detention. Their advocacy is part of a broader effort to prevent the indecorous deportation of asylum seekers back to China, where they face severe persecution.

On the legislative front, the Uyghur Forced Labor Prevention Act (UFLPA) marked almost two years since its implementation in May. Save Uyghur praised the U.S. Customs and Border Protection for reviewing over 9,000 shipments to prevent forced labor products from entering the country. The Justice For All initiative has supported sanctions and regulatory efforts against entities complicit in these unlawful practices, including recent moves to blacklist additional Chinese firms and expand the UFLPA Entity List.

Save Uyghur has also tackled the cultural genocide orchestrated by the Chinese government, condemning the systematic renaming of Uyghur villages and addressing shocking findings, such as China's arbitrary imprisonment of Uyghurs amounting to 4.4 million years revealed by Yale University, and controversial visits by international delegations to Chinese-occupied territories.

Reports linking global industries, like pharmaceuticals, to Uyghur forced labor amplified Save Uyghur's call for accountable corporate actions. Notable highlights include exposing the complicity of major corporations and applauding efforts to sanction institutions involved in forced labor practices.

Furthermore, Save Uyghur's criticism of inadequate international responses to China's genocidal policies, such as weak statements from UN Human Rights bodies and reports on sanctions, has drawn attention to global inaction. Save Uyghur condemned entities and measures that downplayed or ignored the ongoing severe human rights breaches against Uyghurs.

In late 2024, as the world marked the 3rd Anniversary of Uyghur Genocide Recognition Day on December 9, Save Uyghur renewed its commitment to worldwide advocacy, pushing for systemic changes to end the Uyghur genocide. Justice For All continues to champion concerted collective actions, boycotts, and sanctions against human rights violators while supporting community efforts across the globe to demand justice and accountability.

Justice For All's Save Uyghur Campaign remains steadfast in its dedication to highlighting and combating these injustices, exemplifying resilience and advocacy throughout 2024 and into the future.

★ Representing you at the United Nations

We met with over 30 country mission heads to advocate for Justice For All (JFA) human rights campaigns, providing them with reports and memos on critical issues. Regular updates were also shared with the UN Office of the High Commissioner for Human Rights, covering Justice For All campaigns, human rights reports, and updates on Prisoners of Haqq.

As an accredited UN NGO, JFA met monthly with other UN NGOs and the Ambassador chairing the rotating Security Council Presidency. Key issues, including Kashmir, Palestine, Uyghurs, and Rohingya, were raised to request action-oriented discussions, provide recommendations for action and demand formal consultations within the Security Council.



As a member of the Executive Board, JFA collaborated with fellow UN NGOs and CSOs on the NGO Committee on Human Rights to the UN and the Committee for Religious NGOs to the UN. Our joint efforts included planning and conducting programs, issuing statements, and coordinating activities.

Justice For All co-organized several high-level side events with NGO allies, such as the Summit of the Future Action Days Side Event: Reversing the Doomsday Clock: Nuclear Disarmament and SSOD-IV and a Day of Action on Burma.

Additionally, JFA participated in and spoke at numerous protest marches at the UN and country missions, highlighting the Rohingya and Palestinian genocide and calling out ambassadors of countries complicit in supporting these genocides.

★ Prisoners of Haqq:



Prisoners of Haqq is a cornerstone project of Justice For All, dedicated to advocating for the release of individuals unjustly detained by oppressive regimes such as India, China, and Israel—often held without due process for their religious beliefs, political views, or peaceful dissent.

Through sustained engagement with the United Nations, U.S. and Canadian governments, and global human rights coalitions, we have pushed for accountability and justice in these cases. In 2024, we welcomed the release of Idris Hasan, a Uyghur activist, after years of coordinated advocacy. We remain in close contact with the families of many current prisoners, ensuring their voices are heard and their struggles are not forgotten.
